ARTICLE 1 - PREAMBULE:

WHEREAS GET-ENST is author and editor of databases, named ENST-Drums databases. The databases in question may be accessed, for some, by downloading them on the web Portal of the Licensor, and for others by getting a copy on digital support of them (DVD, USB Key...).

WHEREAS Each and every downloading and use of ENST-Drums databases is submitted to the acceptance of the conditions of the present License.

WHEREAS Consequently, each and every physical person willing to use ENST-Drums database will not be able to download it and/or to get a copy on digital support of it before signing and returning the present License to the Licensor.

ARTICLE 2 - DEFINITIONS:

- 2-1 « **The Work** » : means every ENST-Drums databases constituting the Work of the Licensor, as describe in exhibit 1.
- 2-2 «**Databases**»: means the ENST-Drums databases that the Licensee may download, say, up to now:
 - ENST_Drums_Audio1
- 2-3 "Licensee": means the physical person willing to use one or more databases, having signed and returned the present license to the Licensor, and who is, therefore, entitle to download and use the databases under the conditions set in the present license.
- 2-4 "Web Portal of the Licensor": means the internet website of the ENST (www.enst.fr) from where the Licensee may download the databases.
- 2-5 **«Parties»**: collectively refers to the Licensor and the Licensee.

ARTICLE 3 - SUBJECT:

The present License aims to define the conditions in which the Licensor give to the Licensee the authorisation to download and/or to get a copy on digital support of the databases and to use them.

The Licensor conserves the prerogative to unilaterally modify at every moment the conditions of the present License.

ARTICLE 4 - TERM AND TERMINATION:

The present License shall enter into force upon its date of acceptation by the Licensor, who entitles the Licensee to download and/or to get a copy on digital support of the databases.

The present license shall remain valid during the legal period of protection granted to the databases.

ARTICLE 5 - RIGHTS TO USE THE DATABASES:

The Licensor grants the Licensee a non exclusive and strictly personal right to download and/or to get a copy on digital support of the databases and to use them.

This authorisation is given to the Licensee in the conditions and the limits exposed in the present license.

This authorisation is given for the personal use of the Licensee only and solely for scientific purposes (for example: illustration, explaination, example, commentary, critics, teaching research and analysis).

Warning: the Licensee acknowledges that the Licensor will not put at its disposal every databases of the Work. The Licensor decides which databases will be accessible by the Licensee and keep the ability to modify his choice at every moment.

The Licensor takes the commitment to inform the Licensee by email whenever a new databases from the Work is made available to him by downloading it and/or by getting a copy on digital support of it.

The present License shall apply to every new databases from the Work that the Licensor is put to the availability of the Licensee.

Therefore, the downloading and the use of such databases would not required the signature of a new License.

ARTICLE 7 - RESTRICTIONS:

- 7-1. The Licensee take the commitment to forbid third part to access the database or to make it technically possible for the public to access the database. Notably, the Licensee take the commitment not to put the database to the availability of the public by mean of the Internet or any other mean..
- 7-2. The Licensee take the commitment not to make any commercial use of the databases without the Licensor previous consent (for example, any sale, complete/partial reproduction, complete/partial distribution, by any mean and in any form of the databases).
- 7-3. The Licensee take the commitment not to modify or to create a derivate work of the databases without the previous consent of the Licensor in written form.

ARTICLE 8 – INTELLECTUAL PROPERTY RIGHTS

- 8-1. The Licensee acknowledge that the Licensor is the owner of the Intellectual Property Rights on the databases.
- 8-2. In the event of a use of the databases by the Licensee for the completion of a work he would disclose to the public by any mean and in any form (report, publication, software, etc.), each and every specimen of the work in question shall quote the following references:

ARTICLE 9 - CONFIDENTIALITE:

The databases are confidential information. The Licensee takes the commitment to maintain this confidentiality by taking any necessary mean to put the databases out of any third reach.

ARTICLE 10 - LIABILITY:

The Licensor does not certify that the information of the databases does not contain error..

The Licensor shall not be liable for any difficulty in the downloading of the data and more generally for any network dysfunction.

The Licensor shall not be liable in any case of any damages, such as the loss of data that could result from problems met in the use of the databases.

When the Licensee is getting the databases from the Licensor on a copy on digital support, the Licensor shall not be liable for any damages, either direct or not, material or immaterial, moral or physical, that might be caused by the copy on digital support in question and/or by its manipulation by the Licensee.

Therefore, the Licensee acknowledges that he is downloading and/or getting a copy on digital support of the databases and using it to its own risks.

It is mutually agreed upon by the Parties that every cost induced by the getting of a copy on digital support of the databases by the Licensee (price of the plain digital support / delivery fees...) shall be borne by him

ARTICLE 11 - MISCELLANEOUS

The present license is interpreted and ruled according to the French law. All disputes arising out in connection with the present license shall be first discussed in good faith between the Parties in order to find a friendly solution..

If they cannot be so friendly solved within a two (2) months delay from the date of their occurrence, and apart from emergency proceeding, such disputes shall finally be heard by the suitable Paris Tribunal.
